Assumption of the Risk, Waiver of Liability and Good Faith Agreement Relating to Coronavirus/Covid-19 & other Viruses

I understand that the risk of becoming exposed to or infected by COVID-19 or other viruses at Spirit Gymnastics LLC may result from the actions, omission or negligence of myself and others, including, but not limited to, Spirit Gymnastics LLC, employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)s attendance at Spirit Gymnastics LLC or participation in Spirit's Gymnastics LLC programming ('claims").
